**Subject :-** Granting Renewal Certificate of School necessity of Right of Free Compulsory Education to Children Act, 2009 under section 18 and under Rule 11, Sub - section 4) of Right of Free Compulsory Education to Children Rules, 2011

As per above mentioned letter No. of Block Education Officer, P.S. Khamgaon vide letter No. PSK/2023/2023 Dtd. 06/06/2023 and as per recommendations in Inspection Report I, Education Officer (Primary) Zilla Parishad Buldana grant temporary permission for 3 years from 01/04/2023 to 31/03/2026 for Std. 1 to 8 to SANSKAR DNYANPEETH, KHAMGAON (27040301757) on following terms and conditions

- 1) The duration of recognition will not be extended and after 8th Standard recognition and affiliation will not be binding in any condition
- 2) Free and Compulsory Education to Children Act 2009 ( annexure One) and Maharashtra Right of Free and Compulsory Education to Children Rules 2011 (annexure Two) in which the precisions are made the school will follow them
- 3) The children belonging to Below Poverty Lane and deprived from education residing nearby admitted to the education to the school @25% out of total strength and will impart education to them Free and compulsory education till they complete the primary education The same percentage will be applicable for Pre-Primary Standard.
- 4) The school will be granted compensation under Section 12 (2) of the Act for the children mentioned in para 3. For receiving such compensation the School will have to open separate Bank Account
- 5) The Sanshta/School will not recover any Capitation Fee and will not complete the child or his/her parent or guardian for any fabricated method
- 6) No admission of the child will be rejected for want of age proof, religion, caste or creed. place of birth.

- 7) (i) The child admitted in any standard should not be detained in the same standard or he will not be removed from the school till he/she completes the primary education.
- (ii) No child will be torched physically or mentally
- (iii) It will be necessary for the child to pass the examination of any Board till he/she completes his/her primary education
- (iv) The child will be awarded certificate as per Rule 23 after completion of primary education.
- (v) The children who are handicapped/specially needed will be admitted as per provisions of the Act
- (vi) Teachers will be appointed who possess minimum qualification as per section 23 (1) of the Act. But the teachers who do not possess minimum qualification before this Act they will have to acquire the minimum qualification with five years.
- (vii) Teachers will discharge their duties as laid down in Section 23 (1) at the Act
- (viii) The teacher will not engage himself/herself in Private Tutions and the school will observe the same
- 8) The Institution will follow the contents of the books in the syllabus prescribed by the authority.
- 9) The students will be admitted in the school as compared to the facilities available as per section 19 of the Act
- 10) Standard and authentic rules should be followed as per Section 19 of the Act

- 15) The accounts of the school should be audited from Chartered Accountants duly certified by him. Statements should be prepared as per rules. The Statement of each year should be submitted District Education Officer.
- 16) The Code No. granted to your school is 27040301757 This code no should be mentioned in correspondence, which please note.
- 17) The reports and information as demanded by Director of Education/ distrc Education Officer should be submitted from time to time. Compliance should be carried out or instructions should be followed for permanent recognition of the school.
- 18) The office should be informed regarding any change/Renewal of Registration of the Society.
- 19) Other Terms are mentioned in annexure "Three".
- 20) The Temperary Recognition is granted subject to made available Fire Fighting equipments.
